


WHAT IS SAFE SPORT?

SUPPORT SAFE SPORT


- Adopt the Safe Sport Policy Package

MALTREATMENT


Any volitional act by an individual that results in harm or the potential for physical or psychological harm to another Individual.


PREVENTION:

- Whistle Blower






A person of authority should never be alone with a Student/Athlete!

MOST COMMON MISCONCEPTIONS

MYTH – We don't have a need. Everyone is well-intentioned and gets along **REALITY** – It just takes one!

MYTH – We don't have time & resources to deal with this (Costs too much)

REALITY – When something happens it will be too late – need preventative measures now!

REALITY – Without these policies you still have to manage situations with higher costs

MYTH – We can handle any issues ourselves
REALITY – Clubs that have gone through situations
often discover their policies are not thorough enough &
look to the PSA for support. Conflict of Interest issues
Legal fees, time and expertise become a lot regardless
of club size.

MOST COMMON QUESTION:

Q: We are a cruising club or a social club, (don't offer any learn to sail or racing type programs) do we need to do this?

A: Yes. All organizations need to adopt the policy package as it stands. The expectations for behaviour apply to all interactions at the club including between members and volunteers.



NEXT STEPS:

Executive adopts the policies by 1 April 2023;

Policies are made available for the membership to read, and understand;

The Sailing school must use registered instructors and officials;

All members, students, parents, volunteers of CBYC must sign the Code of Conduct Form;

If you see something, say something.

All complaints/incidents will be heard and processed as per policy instructions
